## **“M3” YOUTH PROGRAM – SUMMER CAMP ADMINISTRATION**

### **ROLE OF THE INSTRUCTOR/VOLUNTEER/SPEAKER:**

**M3** provides well respected community members an opportunity to showcase their field and teaching expertise and/or LIFE Experiences. The teacher/speaker is expected to design thier: lesson, lecture, presentation, activity, course and/or camp (if applicable); effectively convey the information contained in our PROGRAM UMBRELLA curriculum as described to participants in the schedule, maintain a professional appearance representing **M3** at its best, and to provide positive leadership.

The instructor/speaker/volunteer suggests and then works within the **M3** guidelines to determine the scheduling, materials, equipment, and any anticipated expenses.

The **M3** Program Administrator (**WILLIAM E. WEST**) and Curriculum Coordinator are available to assist in planning. For those that are interested in servicing an additional **M3** program/camp the Program Administrator will coordinate additional details such as but not limited to program/camp administration, program/camp location, participant registration, and publicity/advertisement/marketing.

### **EMPLOYMENT ELIGIBILITY:**

**M3** is required to ensure all adults and young adults alike; including faculty, staff, students, speakers and volunteers who may come into contact with minors submit to a criminal background check and are **NOT** listed on the sex offenders’ registry. The Program Administrator will run a background check by way of The Mentoring Center of Ohio for all involved in the program/camps. If an unfavorable result is discovered the Administrator may take action related to your future or existing position with **M3**. Public Act 129-131 and 138 require you, as an employee of **M3** to self-report to your employer within three days when you have been arraigned/charged with certain crimes as listed in MCL.380.1535a.

Criminal background checks are just one piece of **M3’s** comprehensive approach to evaluating the background of the summer program/camp instructors, assistants, volunteers, and/or speakers and their acceptability to work with youth. Our standards also require reference checks, personal interviews, and work history reviews. The screening requirements, along with strong training and supervision guidelines, combine to provide a comprehensive approach to child protection.

**A. Non-Employees:** If you are **not** an employee of **M3** you must include your resume when submitting the program/camp proposal form. Approved proposals will require a complete **M3** employment application and background check for all individuals working with minors. Employment will be contingent upon the outcome of the background check, employment verification, and marketability of the program/camp you are proposing.

**B. Employees:** If you are an employee of **M3**, and/or taught a summer program/camp last year elsewhere, and are approved to teach a 2019 summer program/camp with us you will be required to complete a current background check.

**C. Volunteers & Speakers:** Any program/camp requiring the assistance of volunteers must prepare an outline of what the volunteer’s role and/or involvement will be in the camp and include it during the proposal-planning phase. All adults, including students and volunteers, who may come into contact with minors will be required to submit a criminal background check and must not be listed on the sex offenders’ registry.
